The State of Ohio established the "Forever Buckeye" provision in the FY 2012-2013 budget. This provision extends the in-state resident tuition rate to any public or private Ohio high school graduate who left Ohio, but returns to enroll an Ohio college and also establishes residency in Ohio by the first day of classes of the requested semester (Revised Code 3333-1-10). The Forever Buckeye provision removes the 12-month period of establishing domicile in Ohio before becoming eligible for in-state tuition rates.

The following documents must be submitted with this form:

- a) your Ohio high school transcript or a verification of your graduation on the high school's letterhead stationary; and (Note: A copy of a high school diploma is not sufficient evidence of high school graduation. The provision does not apply to students who received an Ohio GED.) If you are not a U.S. citizen, you must attach copy of supporting documents establishing your current immigration or Visa status.
b) your current housing lease, property deed, or notarized affidavit from parents/other.

\*Requests for residency must be approved prior to or on the first day of classes of the academic term you desire reclassification; therefore, application materials and all appropriate documentation must be submitted the first day of the term. Retroactive residency determinations cannot be made for tuition surcharge purposes. Application deadline is the 1st day of the term being requested.
