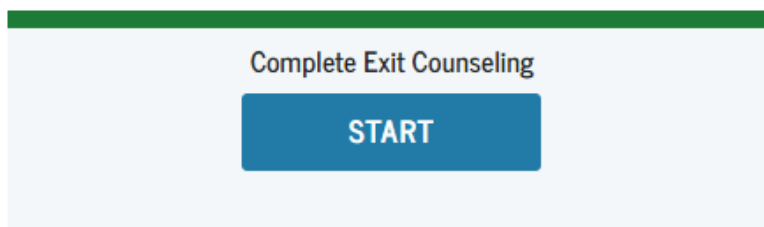
If system monitoring reveals information indicating possible criminal activity, such evidence may be provided to law enforcement personnel.
